

# Advice & Guidance In-light of Microsoft 365 Storage Price Increases

## What is the issue?

**What are the changes and what how will this impact Microsoft 365 license holders.**

*'Beginning at a school's next contract renewal, but no sooner than August 1, 2024, all school tenants will receive 100TB of free pooled storage across OneDrive, SharePoint, and Exchange, with additional pooled storage per paid user, depending on your subscription.'*<sup>\*</sup>

The above is an extract from Microsoft information and although Microsoft state this as a positive, the reality is that existing education establishments have been using their Microsoft 365 Tenants without any restrictions. This change, from their perspective, is a new restriction and will no doubt, be perceived as a price rise, since many education tenants are larger than 100TB.
